NOTICE OF PROPOSALS

NOTICE IS HEREBY GIVEN that Boston Borough Council propose to make the above order (hereafter called “the Amending Order”) to vary and amend The Borough of Boston (Off-Street Parking Places)(Civil Enforcement and Consolidation) Order 2012 (hereafter called the “Original Order”), as previously amended, to the extent shown below. In all other respects the Original Order will remain in force as previously amended.

Commencement

It is intended to bring the Amending Order into operation on or after 12 April 2017.

Amendments

The effect of the Amending Order, if made, will be to:-

Remove:-

Fountain Lane and County Hall Parking Places

Redesignate :-

Tunnard Street vehicle class so that it includes public service vehicles in designated areas only. The rest of the car park will retain the ‘vehicles not exceeding 3020kg’ class.

The category of Irby Street from long to permit only.

Alter:-

The spelling of Spayne Place to Spain Place.
