### 1. NOMINATION PAPERS

Nomination Papers may be obtained from the Parish Clerks or offices of the Returning Officer, Municipal Buildings, West Street, Boston, PE21 8QR who will, at the request of any elector for the electoral area, prepare a nomination paper for signature.

### 2. DELIVERY OF NOMINATION PAPERS

Nomination papers must be delivered to the Returning Officer, Municipal Buildings, West Street, Boston, PE21 8QR on any day after the date of this notice, Monday to Friday (excluding Bank Holidays), between the hours of 9 a.m. and 4 p.m. but **not later than 4p.m. on Wednesday 3<sup>rd</sup> April 2019.**

### 3. POLL

If any election is contested the poll will take place on **Thursday 2<sup>nd</sup> May 2019.**

### 4. REGISTER TO VOTE

Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on Friday 12<sup>th</sup> April 2019. Applications can be made online: [www.gov.uk/register-to-vote](http://www.gov.uk/register-to-vote)

### 5. ABSENT VOTES

Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at Municipal Buildings, West Street, Boston, PE21 8QR by **5 pm on Monday 15<sup>th</sup> April 2019.**

New applications to vote by proxy at this election must reach the Electoral Registration Officer at Municipal Buildings, West Street, Boston, PE21 8QR by **5 pm on Wednesday 24<sup>th</sup> April 2019.**

### 6. EMERGENCY PROXY VOTES

Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at the Municipal Buildings, West Street, Boston, PE21 8QR by **5 p.m. on Thursday 2<sup>nd</sup> May 2019.** The physical incapacity must have occurred after 5 pm on Wednesday 24<sup>th</sup> April 2019. To apply on the grounds of work/service the person must have become aware that they cannot go to the polling station in person after 5 p.m. on Wednesday 24<sup>th</sup> April 2019.
